- 06 Student must have access to a working PC or laptop with a configuration suitable to meet study requirements. Please seek your trainer/assessor assistance in this regard.
- 07 Student must have sound digital literacy and access to working internet.

- ① Please Note: It is highly recommended that students must have successfully completed 'CPCCWHS1001 Prepare to work safely in the construction industry', prior to commencing this course as this unit of competency is a pre-requisite to most of the units contained within the qualification.
